# Part A: Pupil premium strategy plan

## Statement of intent

At Preston Candover C E Primary School, we adhere to the seven 'building blocks' which form our strategy to improve outcomes for our disadvantaged pupils:

- **Whole-school ethos of attainment for all**  
There is an expectation that all pupils should achieve high levels of attainment. There is an ethos that all disadvantaged pupils can overcome their personal barriers to succeed.
- **Addressing behaviour and attendance**  
The school responds rapidly to ensure behaviour management strategies are effective for pupils that need support. Attendance is monitored. Strategies, where applicable, are implemented to improve absence or lateness to maximise opportunities for learning in school.
- **High quality teaching for all**  
The school places a strong emphasis on ensuring all disadvantaged pupils receive high quality teaching; responsive on-going formative assessment is essential to ensure disadvantaged pupils make strong progress.
- **Meeting individual learning needs**  
Personalised profiles are to ensure barriers are overcome so that disadvantaged pupils can benefit from enrichment, emotional well-being support and interventions that enable them to succeed in their learning across a wide range of subjects.
- **Deploying staff effectively**  
Both teachers and support staff are deployed flexibly in response to the changing learning needs of disadvantaged pupils.
- **Data-driven and responding to evidence**  
The progress of disadvantaged pupils is discussed at all pupil progress meetings and at key assessment milestones. Actions are identified, implemented and regularly reviewed through our class Provision Maps within each assessment phase.
- **Clear, responsive leadership**

The inclusion leader reviews the effectiveness of strategies with the headteacher and governors at the end of each assessment phase. English and mathematic leaders are directly involved in monitoring activities designed to secure good progress.

## Challenges

This details the key challenges to achievement that we have identified among our disadvantaged pupils.

Challenge number	Detail of challenge
1	Emotional well-being and readiness for learning. Development and understanding of independent learning skills leading to learners being able to demonstrate self-motivational skills and know how to learn independently.
2	Under developed social skills, ability to make relationships, resilience and maintaining friendships.
3	Some PP pupils may have lower literacy skills and may have less social communication skills. This could be a result of having had less exposure to a wide range of literature and spoken language support than their peers. This can impact on their comprehension, mathematical problem-solving skills and understanding of aspects of the curriculum.
4	Attendance for all PP to be maintained at 96% or above academic year 2021-2022 which will impact on their learning.
5	Access to extra- curricular, and enriched education activities and experiences including trips, music lessons, sports activities, visits and residential experiences.

## Intended outcomes

## Part B: Review of outcomes in the previous academic year

### Pupil premium strategy outcomes

This details the impact that our pupil premium activity had on pupils in the 2021 to 2022 academic year.

Attendance for all pupil premium children was 95.9%, which was higher than the whole school attendance of 94.5% for the academic year.

The school Inclusion Leader worked with some pupil premium children through a research project and noticed a development in emotional well-being and resilience in their learning through following the Leader in Me programme. Leader in Me had an impact on all pupil premium children's confidence across the school; due to the leadership roles, they were given. Including two children in Key Stage 2 who ran their own graphic designer club, which was extremely successful.

Pupil progress meetings allowed all staff to discuss each child's attainment and review provision and interventions. All pupil premium children received extra provision, which was personalised and evident in all class provision maps. All pupil premium children received high quality learning experiences through a broad curriculum.

In the phonics screening assessment in Year 1, 2 out of 4 pupil premium children achieved age related expectation. The other 2 children narrowed the gap significantly, showing good progress from the beginning of the year. This was achieved through using Little Wandle, 1:1 reading and keep-up phonics interventions.

All pupil premium children in KS2 received reading comprehension intervention support from a qualified teacher. 100% of KS2 pupil premium children achieved age related expectations in reading and writing, including a child who met the greater depth standard.

All children received access to the Library online service, school and class libraries. Staff supported all pupil premium children to complete their story wings to enhance literacy skills, which enable 100% of KS2 children to receive their story wings badge.

All KS2 children were invited to singing and song writing club, which boosted their self-esteem, confidence and ability to express themselves through their writing and performance.

4 out of 5 children from KS1 attended an after school club: Drama and book club, Nature club and football.

The Year 5 and 6 residential was subsidised for all pupil premium children.

All school trips, workshops, after school clubs and visitors were subsidised for all pupil premium children, ensuring that they all had access to enriched extra-curricular learning experiences.
